## I. COMPANY PROFILE

GAIL (INDIA) Limited was incorporated under the Indian Companies Act, 1956 with the objective of accelerating and optimizing the effective and economic use of Natural Gas and its fractions for the benefit of national economy.

GAIL handles diverse post-exploration and production activities relating to Natural Gas i.e. transportation, processing distribution and marketing of gas and its fractions and byproducts. It is schedule 'A' Maharatna CPSE win the administrative jurisdiction of Ministry of Petroleum & Natural Gas. The company employed 4530 regular employees [Executives 3632, Non-executives 898] as on 31.03.2019.

Its Registered and Corporate offices are at New Delhi.

The authorized and paid up capital of the Company was Rs.5,000 crore and Rs. 2,255:07 crore respectively as on 31.03.2019.

The shareholding of the Government of India in the company is 52.19%.

## II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Projects) is a full time functional director and a member of the Board of Directors of the Company. Director (Projects) reports to Chairman and Managing Director, GAIL. He has an overall responsibility for Projects Planning & Execution and Operations & Maintenance of all installations spread across the country.
