I. COMPANY PROFILE

GAIL (INDIA) Limited was incorporated under the Indian Companies Act, 1956 with the objective of accelerating and optimizing the effective and economic use of Natural Gas and its fractions for the benefit of national economy.

GAIL handles diverse post-exploration and production activities relating to Natural Gas i.e. transportation, processing distribution and marketing of gas and its fractions and byproducts. It is schedule 'A' Maharatna CPSE with the administrative jurisdiction of Ministry of Petroleum & Natural Gas. The company employed 4530 regular employees [Executives 3632, Non-executives 898] as on 31.03.2019.

Its Registered and Corporate offices are at New Delhi.

The authorized and paid up capital of the Company was Rs.5,000 crore and Rs. 2,255.07 crore respectively as on 31.03.2019.

The shareholding of the Government of India in the company is 52.19%.

# II. JOB DESCRIPTION AND RESPONSIBILITIES

The Chairman and Managing Director is the Chief Executive of the Corporation and accountable to its Board of Directors and Government. He is responsible for the efficient functioning of the Corporation for achieving its corporate objectives and performance parameters.
